	Now, add or remove a country (e.g. keep Spain and France, remove Zambia and
	add Germany selected). Save and close the line

	You should not get an error message on the "Country of origin" missing.
	Doble click the commodity line to open it
	The "No element found" message should not be displayed.

	Steps:


- Save the line

- Scroll down to edit the treatment
- Amend treatment information and click "Confirm" then "Save"
- Reopen the commodity line
- The amendments on the treatment should be reflected

[MADAGASCAR User Feedback] "Find an issued certificates" functionality on login should be working even if there is an extra blank space.

Steps:

- As NPPO Admin log in and make sure this configuration is enabled under Administration > System Settings → "Enable the public search of Phytosanitary Certificates on login page"
- Open a PC that has been issued (status can be ISSUED, REPLACED or WITHDRAWN)
- Click "Print" to download the PDF and copy its PC number, place of issue and issue date.
- Then, log out.
- On login page click "Find an issued certificate"
- Type Certificate Number, Place of Issue and select the Date of issue.
- Check the reCAPTCHA box, then "Search"
- The PC should be available for downloading.

Log in as NPPO Assistant or Company User

- Create a Certificate Request (CR) for Export or Re-export
- Add Means of transport in the "Consignment" tab
- Add the commodity line

Scenario 1 - Steps:

Go to "Attachment" tab and add a file under and over 3 MB

- ♣ Go back to "Consignment" tab and submit the CR to the NPPO Inspector
- ♣ Log in as NPPO Inspector and verify that transport details are still displayed.

Scenario 2 - Steps:

- ♣ Log in as NPPO Assistant or Company User
- Copy a Certificate request (CR) including Transport details
- Go to the "Attachment" tab and add a file under and over 3 MB
- Go back to "Consignment" tab and verify that transport details are still displayed.

Scenario 3 - Steps:

- ♣ Log in as NPPO Assistant or Company User
- Either create a Certificate Request (CR) with transport details or copy one including Transport details
- ♣ Go to the "Attachment" tab
- Add a file, then remove it
- ♣ Go back to "Consignment" tab and verify that transport details are still displayed.

[Replacement] Align the Issue Date in the XML and printout

Requirements:

- ♣ The NPPO Assistant or Company User raising the replacement request, can select any Date of replacement. However, by default the Replacement Date should be the issued date of the potential replaced certificate.
- The NPPO Officer who receives the Replacement Request can select any issue date. This selected date will be displayed on the printout and as issue date in the XML.
- ♣ The ADRD (replacement date) in the XML will be kept as the issued date of the replaced certificate despite the selection of the NPPO Assistant or Company User.

User should not lose Country of origin and location on any Certificate copy

Steps:

- Look for any certificate with a commodity line.
- Then, copy this certificate
- ♣ Double click the commodity line
- then, click "Submit"
- At this stage there should not be any error message, and the Country of origin should be visible.



IGN-3360

User should not lose Country of origin and Contracting party of origin on Re-export certificates from Import.

Steps:

- ♣ Go to the Import folder > Received
- Re-export a certificate
- Add the mandatory info (importing country, applicant name if applicable, exporter and consignee).
- Click "Submit"
- At this stage there should not be any error message, and the "Country of origin" and "Contracting party of origin" should be visible.

	Click "Commodities" tab
	Open the Commodity line
	Always show the packaging information of the original certificate.
